Most importantly, you will leave feeling empowered to advocate for children with complex and specialized needs, while maintaining positive relationships with the many parties involved.

## **Promise of Permanency**

When the State removes children from their homes, there is an implied promise to effect permanency for them both timely and compassionately, and with as little trauma as possible. In this workshop, participants will discuss factors that should be considered in determining the most appropriate permanency goal for each child and family. For decades, federal policy has driven adoption as a preferred permanency option for children in foster care. Because of this, termination of parental rights and adoption has become the second most common permanency option in Georgia, outstripping less drastic outcomes. Relational permanency is often overlooked in the rush for the "more permanent" legal outcome. It may be time to re-think what permanency means for children in foster care.
